THE COMPANIES ACT, 2013 MEMORANDUM OF ASSOCIATION OF A COMPANY LIMITED BY SHARES

OF

SAYAJI HOTELS (PUNE) LIMITED

- The name of the Company is SAYAJI HOTELS (PUNE) LIMITED.
- II. The Registered Office of the Company will be situated in the State of TAMIL NADU (within the jurisdiction of Registrar of Companies, Chennai).
- III. The objects for which the Company is established are :
- (A) THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION:
- To own, construct, run render technical advice in constructing, furnishing and running of, take-over, manage, carry on the business of motel, hotel, restaurant, cafe, tavern, bars, refreshment rooms, boarding and lodging house keepers, clubs, association in India and to provide lodging and boarding, restaurant, eating houses, bakery, confectionery, bar, swimming pools and other facilities to the public including tourists, visitors and delegates coming to India from foreign countries and to allow Indian as well as foreign delegates to hold international conferences, seminars etc. and to give all facilities to members of delegations, missions form abroad and foreign countries and to encourage and carry on and facilitate tourist trade in India.
- (B) THE MATTERS WHICH ARE NECESSRY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE 3(a) ARE:-
- To apply for, tender, purchase or otherwise acquire any contracts, licenses or concessions
 for or in relation to the objects or business here in mentioned or any of them and to
 undertake, execute, carry out dispose of or otherwise turn to account for the same
- To lend and advance money or give create to such persons, Companies, Corporations or firms and on such terms as may seem expedient and in particular, to customers and others having dealings with the Company and to discount bills and to receive money on deposit at interest or otherwise or valuables and to release or discharge any debt or obligation owing to the Company.
- To purchase, take on lease or in exchange, hire or otherwise acquire any movable or immovable property, patents, license rights or privileges which the Company may think necessary or convenient for the purposes of its business.
- 4. To acquire and undertake the whole or any part of the business, property or any liabilities of any person or Company carrying on or proposing to carry on any business which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the Company.

 Subject to the permission of the Competition Act,2002 to amalgamate, enter into partnership or into any arrangement for sharing profit, union of interests, co-operation, joint venture or reciprocal concession, on or limiting competition with any person or Company

- 18. To procure the Company to be registered, incorporated or recognized, in or under the law of any place outside India and to do all acts necessary for carrying on in any foreign country any business or profession of the Company.

To establish or promote or concur in establishing or promoting any Companies or company for the purpose of acquiring all or any of the Property, right and liabilities of the Company or for any other purposes Which may seem directly or indirectly calculated benefit the Company and Part of the shares debentures of other company.
